- F. Receive Treasurer's report as submitted:

Report on actual expenditures to date compared to budget: the report indicates that budget income was over budget by \$77,857.90, and the expenditures were under budget by \$14,067.10.

A motion to approve the budget amendment to record the receipt of APRA funds recently deposited to increase miscellaneous revenue to \$92,872.00 made by Supervisor Magaraggia, seconded by Trustee Sweeney. All in favor, motion carried.

Motion for approval of payment of bills: Motion to approve the payment of unpaid bills to be paid from the General Fund, Fire Fund--\$315.69 General fund--\$12,645.92 as funds become available; and to approve the prior month's activities in the General Fund Checking Account made by Supervisor Magaraggia, seconded by Treasurer Rice. All in favor, motion carried.

 - 2. A motion was made to accept a bid from Payne and Dolan in the amount of \$5800 to pulverize the track at Meadowbrook Field by Supervisor Magaraggia, seconded by Trustee Sweeney. All in favor, motion carried.
 - 3. Mike Grentz reported on the recent audit. The audit went smoothly and we are currently in good financial standing with our general fund balance.
 - 4. Bids were received for the fire truck and a motion was made to accept the highest bid at \$14,600 from Danielson and to pay 5% of the purchase price to Mayo Collision for use of their property by Trustee Lloyd, seconded by Supervisor Magaraggia. All in favor, motion carried.
 - 5. Work will begin on the Sewer line in the Hall and on the front of the building remodel within the next two weeks.
 - 6. A motion was made to pay 2020 covid pay to Township employees, including \$3.00 for park employees and Deputy Clerk Mervar, and 20% of wages for the custodian by Supervisor Magaraggia, seconded by Trustee Sweeney. All in favor, motion carried.

Clerk's Report: The minute's summary for the regular meeting was sent to the L'Anse Sentinel for publication; minutes were printed and sent by email to board members, posted on the town hall bulletin board, posted to the website, and accepted minutes placed in the minute book; papers resulting from board actions were placed in the regular meeting folder for 2021 in the treasurer's office; checks were signed for payment as prepared by the treasurer for bills approved at the September meeting. Election official training is due for Clerk Kahler on December 31. In person training in the area is not currently available.
